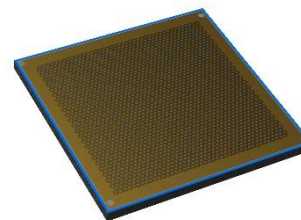

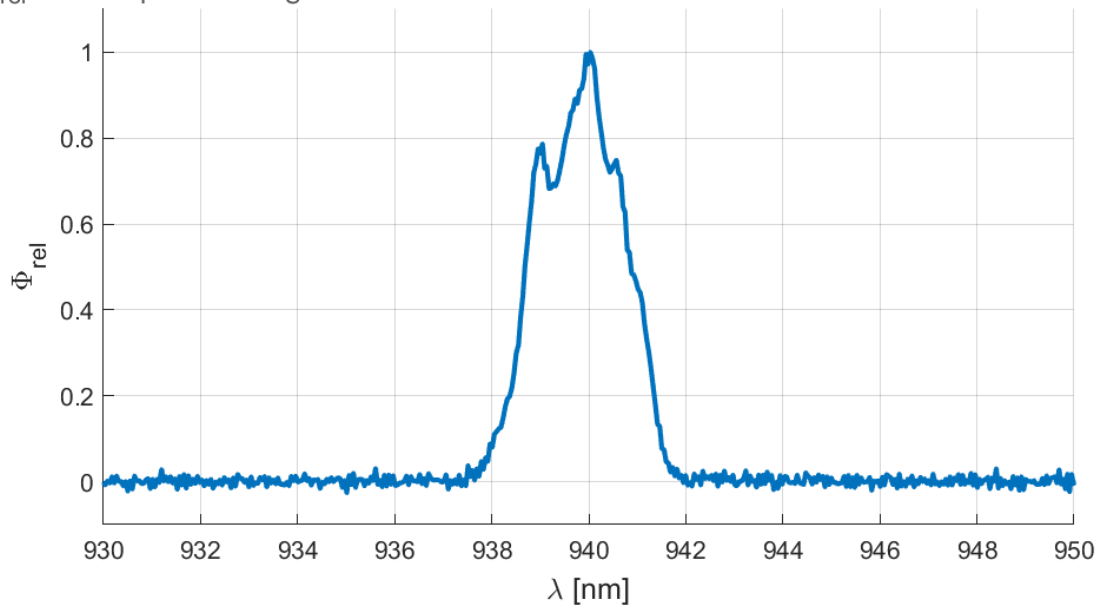

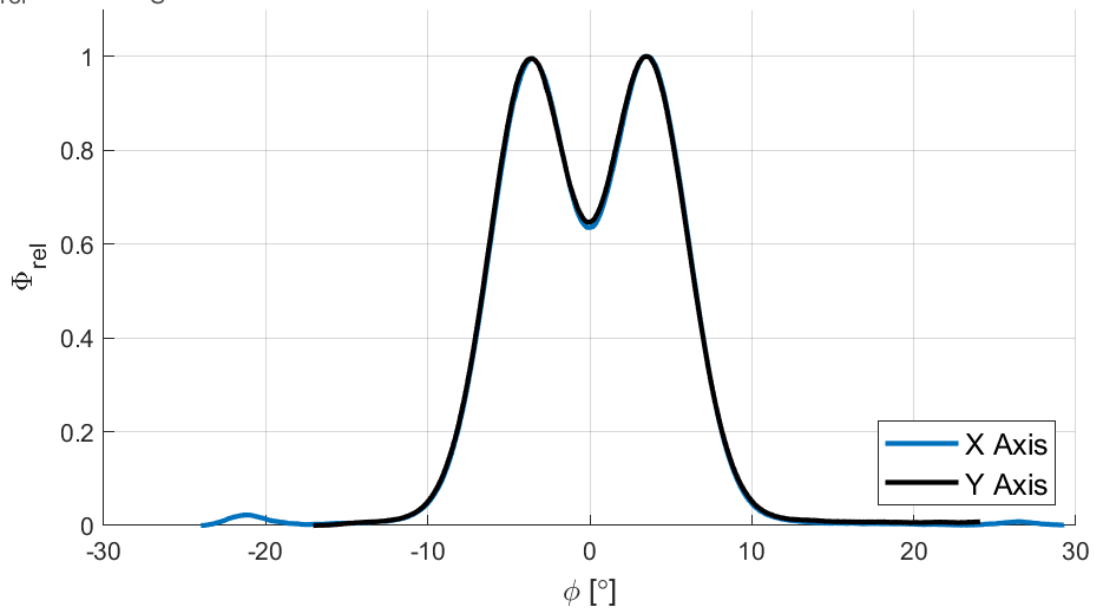
Relative Spectral Emission ¹⁾

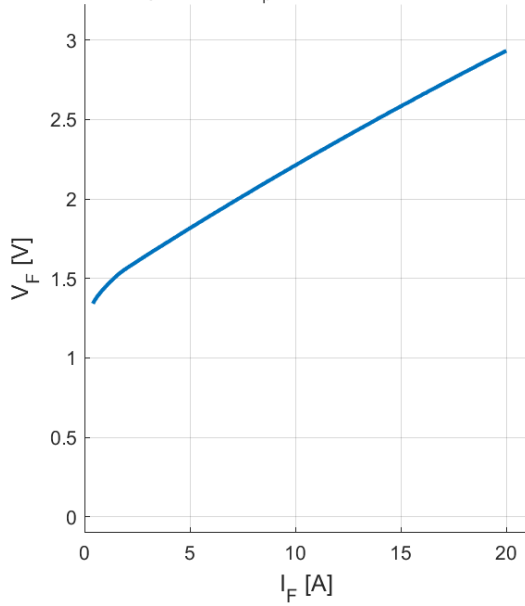
Radiation Characteristics ¹⁾

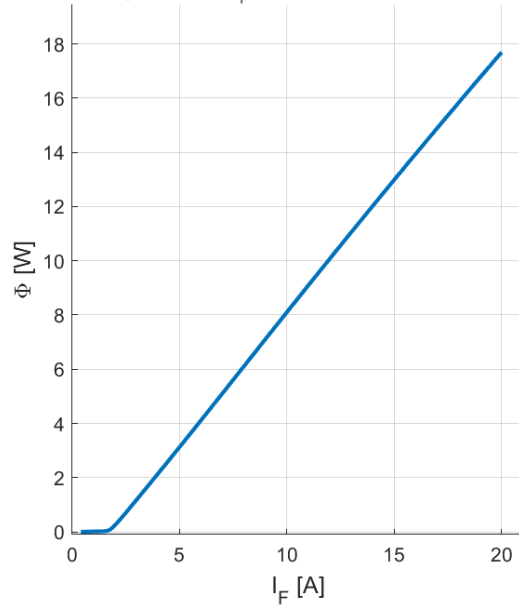

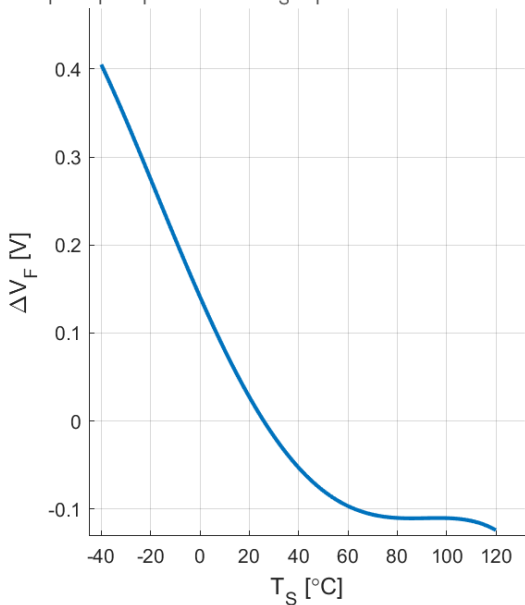
Optical Output Power ^{1) 2)}

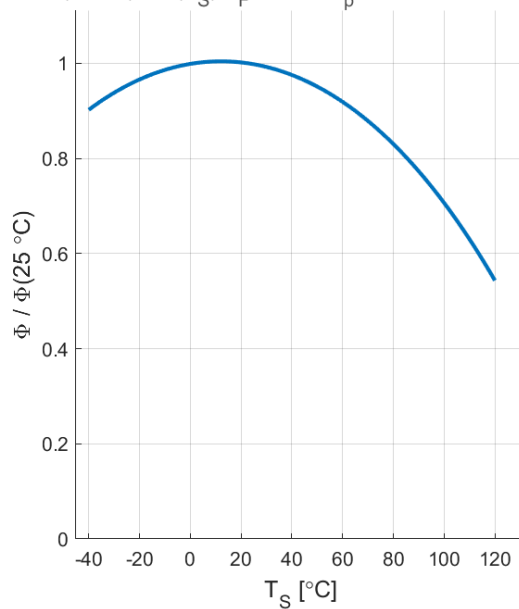
Relative Forward Voltage ¹⁾

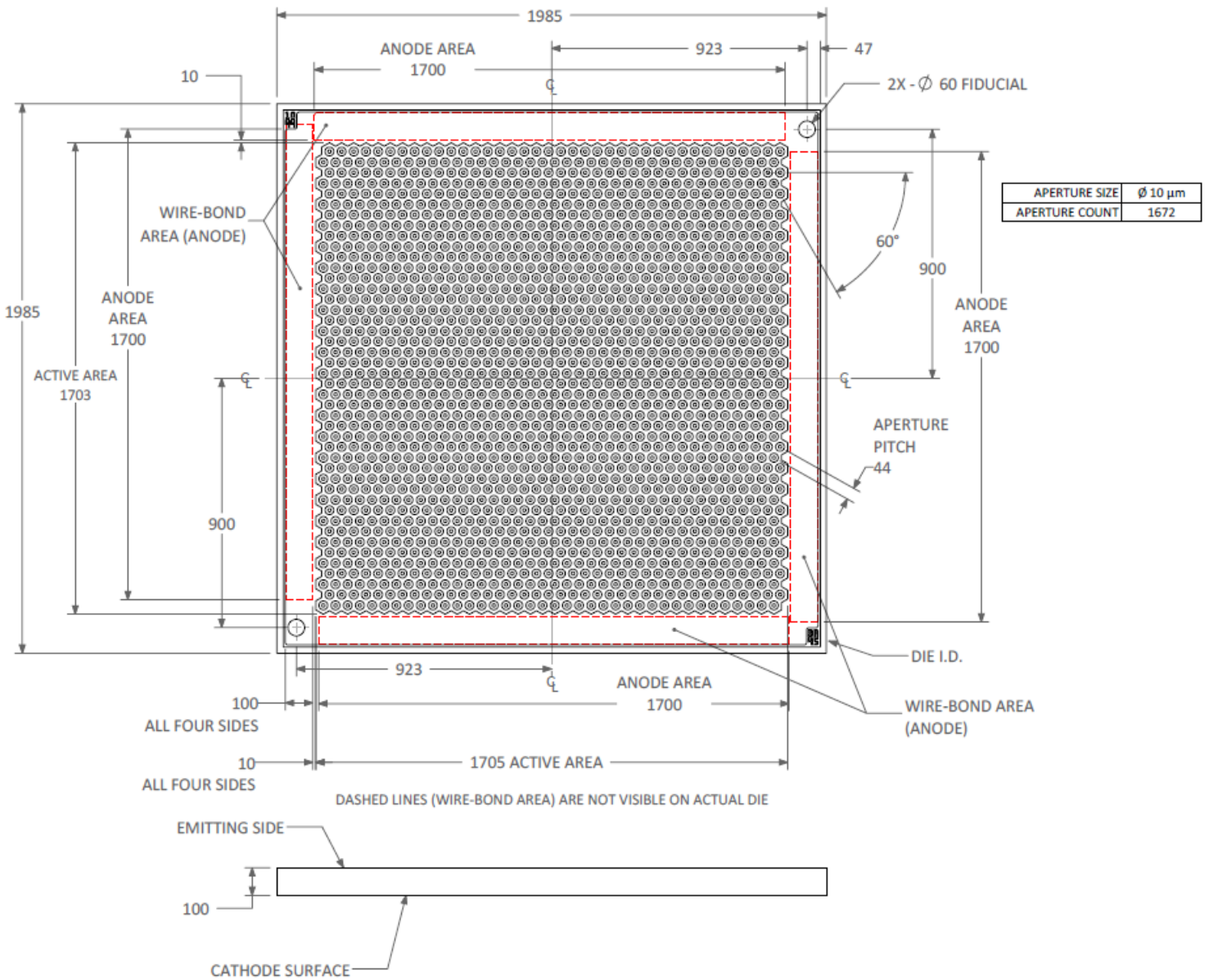


Relative Radiant Power ¹⁾
